ABOUT THE POSITION

As part of the Health & Safety Team, the Health and Safety Advisor will promote health, safety, and training aspects of the Back River Project working on a rotational basis (3x3) in a remote camp setting. Reporting to the Supervisor, Site Safety or Designate, the Health and Safety Advisor works with all members of the Back River Project to ensure that the health and safety objectives are achieved and supports a positive health and safety culture.

PRIMARY RESPONSIBILITIES

Reporting to the Supervisor, Site Safety, duties will include, but are not limited to:

- Ensure a safe environment for all project employees, contractors, and visitors;
- Promote and implement controls to ensure compliance with relevant acts and regulations, promote continuous improvement of performance through Health & Safety programs and procedures;
- Perform safety related inspections, assist with incident investigations, and aid departments with job hazard analysis development to ensure compliance of relevant acts, regulations, and Sabina's Health & Safety program;
- Support and promote a positive Health & Safety Culture;
- Uphold business continuity and emergency management plans and procedures;
- Support the promotion of the Corporate Health & Safety Management System; and,
- Provide assistance as required to the Safety Team & Operations Team. Other duties as assigned by the Health & Safety Supervisor.

DESIRED QUALIFICATIONS

The successful candidate will have prior experience working in a remote camp setting with limited access to resources. Additionally, they will have:

- Three (3) years of experience in Health and Safety role required, preferably in the mining, heavy, or construction industry;
- Bachelor's Degree in related field or equivalent experience required;
